2. From the Member-Secretary, Tamil Nadu State Council for Higher Education, received letters dated 6.9.2022 and Rc.No.5431/2022 A dated 23.9.2022.

ORDER:-

In the letter second read above, the Member Secretary, Tamil Nadu State Council for Higher Education, has forwarded the resolution passed by the Chairpersons, Board of Studies-Commerce held on 16.9.2022 and subsequently approved by the Chairman, Equivalence Committee / the Principal Secretary to Government, Department of Higher Education, that the degree B.Com (Corporate Secretaryship - Direct III Year), awarded by University of Madras to Tmt.P.Poorkodhy, enrolled during the academic year 2011-2012 (bearing Register No./Enrolment No.A9102UCR6282), is **Not Equivalent** to B.Com for the purpose of employment in Public Services and requested the Government to issue orders in the matter.

2. The Government, after careful consideration, accept the recommendation of the Chairpersons, Board of Studies-Commerce, constituted by the Tamil Nadu State Council for Higher Education, on 16.9.2022, duly approved by the Chairman, Equivalence Committee / the Principal Secretary to Government, Department of Higher Education and direct that the following Degree offered by the University of Madras be not equivalent to the Degree mentioned therein :-

3. The degrees so placed in the Equivalence Committee are however considered as basic degree / post graduate degree, as the case may be, as per the University Grants Commission norms.


