In the letter second read above, the Chairman, Equivalence Committee / Principal Secretary to Government, Higher Education Department has forwarded the resolutions passed by the 3<sup>rd</sup> Equivalence Committee held on 12.11.2019 under the Chairmanship of the Principal Secretary to Government, Higher Education Department, on the non-equivalence of Degrees offered by the Universities / Educational Institutions to the similar Degrees and requested the Government to issue orders in the matter.

2. The Government, after careful consideration, approve the following resolutions passed in the 3<sup>rd</sup> Equivalence Committee held on 12.11.2019 under the Chairmanship of the Principal Secretary to Government, Higher Education Department and direct that the following Degrees offered by the Universities / Educational Institutions be not equivalent to the Degrees mentioned therein:-


