In the letter second above, the Chairperson, Equivalence Committee / Principal Secretary to Government, Higher Education Department has forwarded the resolutions passed by the 4th Equivalence Committee held on 28.11.2020 under the Chairmanship of the Principal Secretary to Government, Higher Education Department, on the equivalence of Degrees offered by various Universities / Educational Institutions to the similar Degrees for the purpose of employment in Public Services and requested the Government to issue orders in the matter.

2. The Government, after careful examination, approve the following resolution passed in the 4th Equivalence Committee held on 28.11.2020 under the Chairmanship of Principal Secretary to Government, Higher Education Department and direct that the following degree offered by various Universities / Educational Institutions be not equivalent to the Degree mentioned therein:-
